For the purpose of looking after your personal information, the data controller will be Aegis. The information above is being collected in order to process your membership with Aegis. We will also use this information in connection with our accounts and general administration, and to inform you of any information that relates to the union that we feel you should be aware of (such as yearly reports). Some data will also be passed to the additional benefits provider – this data will be limited to information required to enable your benefit membership to be created. We receive information periodically from HR, which tells us who is a member of Aegis. This is used solely to update our records.

Aegis may also request information from your HR regarding your up-to-date home address. We will use this information for union ballots, which will be conducted by the Electoral Reform Society, and if we employ a solicitor to act on your behalf.

All communications will be sent to your Office address but if you require that ballot papers be posted to your private address please contact the Aegis Office.

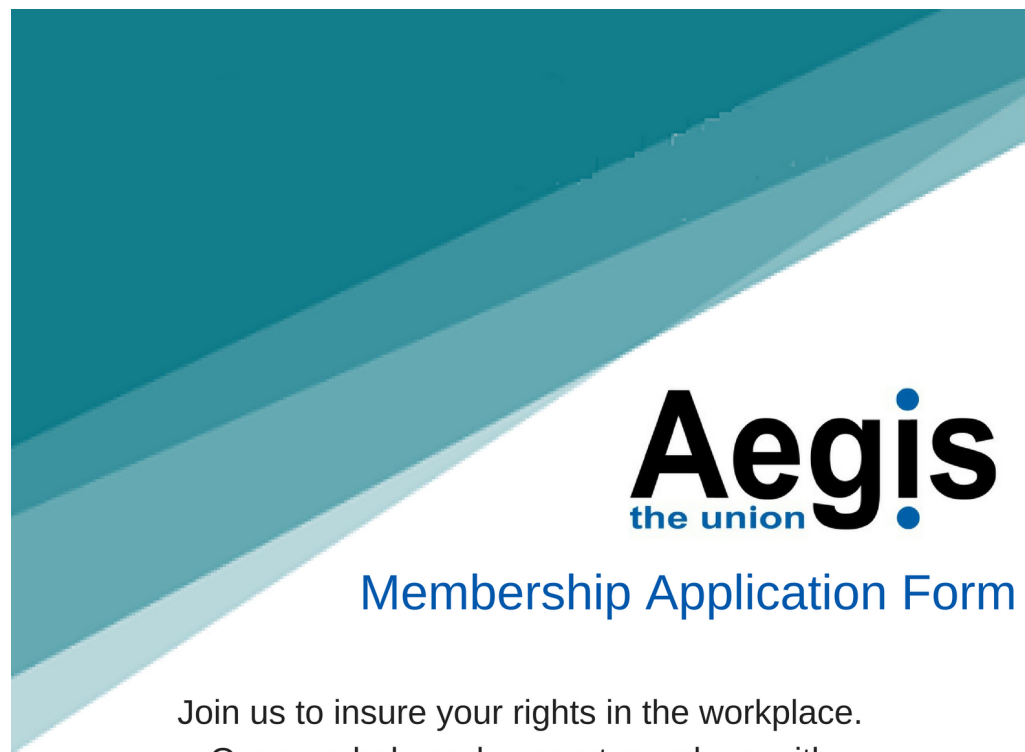
Your personal information will be held securely in our offices and computer system and will not be sold or passed on to any other organisation or used for any purposes other than stated above.
